Lusotopie is a comparatist international journal devoted to the analysis of politics in the broad sense (building and reform of the state, nationalism, elections, ethnicity, neoliberalism, gender relations, racialization of social life, international conflicts and civil wars, media, civil society, cultures, religions, migrations, etc.) within the contemporary spaces stemming from Portuguese history and colonization. *Lusotopie* addresses these topics within the Portuguese heterogeneous post-colonial space, on four continents, and populated by mobile people and transnational communities.
