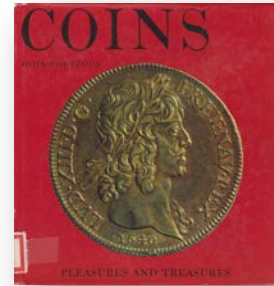

- 1. COINS OF THE GREEKS** 7  
Invention of coinage in the seventh century BC – gold and silver coinage of Croesus and the Persians – ‘turtles’ and ‘colts’ – the unusual technique of coinage in Magna Graecia – the Athenian tetradrachm – fifth-century coin design – the great engravers of the Sicilian coinage – Theodotus of Clazomenae – Philip of Macedon and Celtic imitations – Alexander the Great – the first portrait coins – later Hellenistic coinage
